I agree, as a condition of being allowed to use the ski area facility and premises, that I freely accept and voluntarily assume all risks of personal injury or death or property damage, and release Nashoba Valley Ski Area and its agents, employees, directors, officers, and shareholders from any and all liability for personal injury or property damage which results in any way from negligence, conditions on or about the premises and facilities, the operations of the ski area including, but not limited to, grooming, snowmaking, ski lift operations, actions or omissions of employees or agents of the area, or my participation in skiing/snowboarding or other activities at the area, accepting myself the full responsibility for any and all damage or injury of any kind which may result. Nashoba Valley does not guarantee any specific weather, snow conditions, and/or number of days of operation. Nashoba Valley reserves the right to use any photographs or video footage taken on the premises in which you may appear.

### CONDITIONS OF USE

As a condition of holding a season pass identification card being permitted to use any and all of the facilities of the ski area, I agree to assume all risk of personal injury or loss or damage to any of my property. Passes are not transferable. Passes will be revoked, without refund, by management with due cause. A \$30.00 administrative fee will be charged for the replacement of lost or stolen passes.
